## KEYNOTE SPEAKER LINDSEY STETSON

# BY ELENA MISHKANIAN CAMARILLO RECALL EFFORT

Many Californians are aware of the Gavin Newsom recall, but did you know that there is also a recall taking place in Camarillo to remove two City Council members? A group of concerned Camarillo residents have formed a grassroots effort to recall Camarillo City Council members Susan Santangelo and Shawn Mulchay. The basis of the recall effort is the council

members' attempt to cause the City to endorse Black Lives Matter (BLM), which is an organization that is known to have been founded by trained Marxists who are committed to civil disobedience, and these 2 people are also pushing hard to defund their police department.

Santangelo posted a comment on her Facebook account earlier this year in which she said, "white people are all racists because this world and this country are systemically racist, and we are part of that system." In another statement, she unapologetically expressed her resentment towards people who voted for her saying, "you're all worried about the damn wall to keep out those criminal immigrants while the real killers are the white men walking among us." For a recall vote to take place, at least 20% of Camarillo's registered voters, or about 9,475 people, must sign the petition, and signatures must be collected by April 15th. The City Clerk said that estimates from Ventura County officials could put the cost of a special election to the City at about \$220,000. However, if the recall vote regarding Governor Newsom takes place, the cost to the City should go down based on

sharing the costs involved.

We are blessed as a nation that has the world's longest surviving written charter of government that contains the elements of a true democracy. People in foreign countries that are under dictatorial regimes would be willing to die for the same Democratic rights that we enjoy. Our freedom is the result of "government of the people, by the people, and for the people". We must always proudly stand strong to defend our core values those who would make statements and efforts to contradict the principles of democracy. For over two centuries our constitution has protected us, and now more than ever it is our duty to defend this great document. Those who take our freedom for granted, denigrate law enforcement personnel, and ignore their sacrifices must be held accountable for their actions.

The Camarillo Recall is a non-partisan effort that has attracted concerned Ventura County residents to donate and to volunteer. Residents are volunteering at the weekend booths outside at Trader Joe's, Vons, Ralphs, Sprouts, and the Farmers Market. Please go to www.camarillorecall.org.



# BENEFITS FOR EX-PRESIDENTS

#### THEY RECEIVE A PENSION FOR LIFE

Former presidents receive a pension for life, which today is \$210,700 per year. However, presidents who are impeached and removed from office lose their pension.

# THEY ARE GUARDED BY THE SECRET SERVICE

Since 2013, former presidents get Secret Service protection for life. Prior to 2012, they lost their Secret Service protection after leaving office. Their children get Secret Service protection until they turn 16. Spouses lose their protection if the couple divorces and remarry.

#### THEIR OWN LIBRARY

Modern ex-presidents spend a lot of time on their presidential libraries. It was not always that way. In fact, the tradition started with Franklin D. Roosevelt, who envisioned the Franklin D. Roosevelt Presidential Library and Museum as a place to preserve his personal and presidential records. Before that, presidents simply packed up their records, and many were lost in the process. George Washington's nephew admitted the first president's documents had been "very extensively mutilated by rats and otherwise injured by damp." Planning, fundraising, and running the library can take up a lot of time. Some presidents, like Harry S. Truman, actually worked at their presidential library.

#### THEY AREN'T ALLOWED TO DRIVE

Because of security reasons, former presidents cannot drive on public roads. They are driven by their Secret Service teams. They can drive on their own property, as Ronald Reagan drove on his ranch.

# THE SECRET SERVICE SCREENS ALL THEIR MAIL

The Secret Service receives all mail and packages at an off-site screening place, and they check all mail, to avoid dangerous packages sent to the former president.

# THEY GET PAID STAFFERS, OFFICE SPACE, AND OFFICE SUPPLIES

The government pays for ex-presidents to have an office staff, with a budget of \$150,000 per year for the first 30 months after leaving office. After that, the government foots the bill for \$96,000 in staff expenses, and presidents can pay for any additional costs personally. A paid staff is not the only ex-presidential perk. They also receive compensation for office space and office supplies anywhere in the country.

# THEY GET A HUGE TRAVEL BUDGET

Former presidents get a huge travel budget. They can receive up to \$1 million in security and travel expenses each year, with an additional \$500,000 for their spouse. The funds must be used for travel as an official representative of the US government.

# THEY SPEND A SURPRISING AMOUNT OF TIME PLANNING THEIR FUNERAL

Former presidents can choose to have a state funeral. In fact, presidents must plan their funeral service while still in office, working with the Military District of Washington to design the event. Presidential funerals can include aircraft flyovers, gunfire salutes, and parades. The choreographed events typically last five days, and flags remain lowered around the country. Former presidents can also opt out of a state funeral.

#### SB-5 HOUSING: BOND ACT:

Atkins, Caballero, McGuire, Roth, Ruben, Skinner, Wiener, (D) This bill would state the intent of the Legislature to enact legislation that would authorize the issuance of bonds and would require the proceeds from the sale of those bonds to be used to finance housing-related programs that serve the homeless and low and very lowincome Californians.



owned rail infrastructure designed for speeds in excess of 125 mph. NOTE: Congressman Costa (D) re-introduced HR 867-High Speed Rail Corridor Act legislation that would re-authorize \$32 billion dollars to fund projects in federally designated high-speed rail corridors. This bill will directly assist in funding to complete California's High Speed Rail project through 2025.

### **AB-937 IMMIGRATION ENFORCEMENT:**

(D) This bill would prohibit any state or local agency from arresting or facilitating the arrest, confinement, detention, transfer, interrogation, or deportation of an individual for an immigration enforcement purpose. Additionally, the bill would allow a person to bring action against a state or local agency or state or

local official that violates these provisions.

Existing law requires all basic information stored in state or local criminal offender record information systems to include place of birth. This bill would no longer require that information to include place of birth. NOTE: This bill requires only a majority vote to pass. CONTACT your local Assemblyperson to express your opposition to this bill.

# AB-397 UNEMPLOYMENT INSURANCE: BENEFITS: DISQUALIFICATION: NOTICE:

Mayes (I), Chiu (D) This bill would require the department to provide the above-described notices for each successive disqualification for making a false statement or representation or withholding material facts before the director can extend the ineligibility period. Hmmm....the CA EDD was recently reported as having given out \$10 Billon in fraudulent unemployment claims.

## AB-823 HIGH SPEED RAIL AUTHORITY: TRAINS POWERED BY FOSSIL FUEL COMBUSTION ENGINES:

Gray (D) This bill would prohibit the High-Speed Rail Authority from directly or indirectly using local, state, federal public or private funding to purchase/lease or operate a passenger/freight train powered by diesel engine or other type of fossil fuel combustion engine and from enabling such a train to operate on Authority-

## AB-76 INTER-DISTRICT TRANSFER OF PUPILS: PROHIBITION ON TRANSFERS BY A SCHOOL DISTRICT OR RESIDENCE: IN-PERSON INSTRUCTION:

Kiley (R) This bill will prohibit a school district from prohibiting the transfer of a pupil who is not receiving inperson instruction in a pupil's district to a school district that is offering in-person instruction. This bill would declare that it is to take effect immediately as an urgency statue.

#### **SB-29 ELECTIONS: UPDATE:**

No surprise that the bill THATrequires all registered voters in California to receive mail-in ballots for all elections held in 2021 PASSED in the legislature on 2/16/2021 and was approved by Governor Newsom on 2/19/2021.



# GEORGE WILL ON CHURCHILL

On March 5th, the conservative columnist George F. Will gave the 34th Enid and R. Crosby Kemper Lecture on the 75th anniversary of Winston Churchill's "Sinews of Peace" speech at Westminster College in Fulton, Missouri. In that speech Churchill told America and the world what it did not want to hear: that an Iron Curtain had descended on Europe and the Cold War was upon us. Churchill taught timeless lessons about American power and its responsibilities as well as its limitations. He had learned that there are people in leadership that had little awareness of these limits.

George Will spoke with "Churchillian realism" reflecting on our history and foreseeable future. He reviewed the lessons of Vietnam which did not save us from our inappropriate interventions in Iraq and Afghanistan. He noted that the lessons of must be learned and maintained; perhaps because our leaders, unlike Churchill, are not "marinated in history". Quoting Margaret Thatcher, our nation was not made by history, but by philosophy, a national premise "...that the principles by which we live and that we espouse are explicitly universal." Will noted that the Constitution is our "civil religion". Churchill knew that America could not transfer this philosophy to other nations, or build other nations, which grow organically through their history. We must remember that nothing lasts; including our principles, unless "the only political things that last are the things that we work tirelessly to preserve." Freedom is not directly exportable; among nations and peoples there are many competing values and freedom is but one.

Mr. Will felt that Churchill today might have said that

there is a democracy recession underway around the world, and that further conflict can be prevented by timely action. "What prevents timely action is unrealism. The human tendency to flinch from unpleasant facts." Americans in 1946 were tired of responsibilities abroad and discord at home. The subtext of Churchill's "Sinews of Peace" speech to America is that "for a great nation, for a great Republic, there is no rest, not now, not ever". Although George Will astutely reviewed Churchill's analysis of America's place in the world, much of what he said applies to our domestic political life. We are tired of responsibilities abroad and withered by domestic discord. Will says, "There are those that advocate a kind of tribal nationalism, an ethnonationalism suited for what these advocates call a 'Caucasian Christian nation". Such persons are adversaries to universal natural rights. More importantly, the Left seeks to change America into a Baltic polyglot of tribes each defined by subjugation to universal "white privilege". They see no limits to government. They seek to get rid of political things like the just consent of the governed and equality of all under the law. We will lose our nationhood and our philosophy of forming a more perfect union unless we work tirelessly to make permanent the promises of our founding documents real and present to all in our nation. Life, liberty, and the pursuit of happiness (not equality of outcome) is the inalienable property of all humans regardless of origin or choice. That and only that must be the guiding star in our actions of, by, and for our people. No rest. Not now, not ever.
