I hope you all were able to listen to President Trump's farewell speech on January 19th. It will move you with pride, conviction, hope and strength. With that in mind, where

do we go from here? We have choices. We can continue to see what we lost with President Trump out of the White House and see the damage that Biden administration can do, or the other choice is to choose to Be strong, Be courageous and to Get more involved!

What actions will make a difference in our future and the future of our Country? There are several areas where we can be very impactful. The first one involves voting with our

money. You know the old expression follow the money. When Twitter and Facebook removed the president and many of us off their platforms we complained, we felt dismissed and we bemoaned the lack of our freedom of speech. At the same time these social media sites lost stock value. They lost income due to lack of revenue from ads and promotions on their sites! In other words it is costing them income. So to avoid continuing to be shadow banned or have your site



removed or your information taken down we need to walk away. Remember there is no guarantee that they might not decide to take us off their sites, to "remove our followers" and to filter our communication. Your CRWF is evaluating new social media platforms to start using. We have a new member, Elena Mishkanian, and she will be helping us evaluate alternative social media sites.

Here's another way to vote with your money. When Amazon decided that it would de-platform Parlor (a rapidly growing social media site) it is was a slap in the face to Free Speech and our ability to express our opinions. This is just un-American. I have been doing my best not to buy from Amazon since last year. With stores being shut down and restrictions

placed on what we could purchase within some retailers, Amazon became very wealthy while our local businesses and stores were shut down. Amazon became so strong that you see their trucks everywhere now. In fact, Amazon is building a giant facility several football fields large in Oxnard ready to receive all the things China will be shipping to us. I say they can take their platform and we can "vote" with our money and go somewhere else, I'm not going to take it anymore.

There is another VOTING problem.

After the election hearings were conducted by the Arizona legislators, I watched hours of examples of testimony about election fraud. The good news is that as of January 20th the Arizona Senate now has the authority to go in and evaluate the machines and the documents from the election. A similar situation is going on in Michigan. This may not change the election results; however, it bodes well for future election integrity. In California EIP-CA has filed a lawsuit with the state in reference to election anomalies. As an observer for

four days of California's election I was dismayed to see the rule changes that the Secretary of State had implemented under the Governor's authority. GAVIN NEWSOM VETOED A BILL THAT COULD HAVE GIVEN TAX INCENTIVES TO CALIFORNIA'S 529 COLLEGE SAVING ACCOUNT CONTRIBUTIONS

In September of 2019, Governor Gavin Newsom vetoed Assembly Bill-211, a bill "that would allow an

income tax deduction for contributions to qualified tuition savings programs, known as 529 plans, for qualified taxpayers". The bill was created to "provide a tax incentive to motivate California families to open and contribute to a Scholarshare account, California's 529 college

savings plan account, for the purposes of saving for future college expenses, thereby encouraging more Californians to pursue a postsecondary education and reducing the amount of student loan debt they may accumulate upon graduation" (Section 3. a.1).

Furthermore, the bill would "reduce the amount of student loan debt on a dollar-for-dollar basis, thereby increasing a person's ability to purchase a home, car, and other products that help stimulate economic activity." (Section 3. a. 2). While 11 Assembly members authored it, the other 78 members by voting for it supported the bill, suggesting that this act will motivate Californians to

"open a Scholarshare account and contribute to it while it increases the frequency and amount of contributions" (3. A-C). Unfortunately, Gavin Newsom rushed to veto the bill, declaring that "the 2019 Budget Act made significant investments and expansions in the Cal Grant program". He continued, "the budget act also provided \$50 million to spur the creation of child savings accounts for every child in Kindergarten through establishing a state-level program ...to sponsor or create local or regional child savings account programs." (Bill Status).

Regretfully, Newsom preferred to ignore the fact that the legislators authored this bill using well thought-out reasoning. Throughout the United States, we can find states such as "Colorado, New Mexico, South Carolina and West Virginia where their 529 plan contributions are fully deductible in computing state income tax." Therefore, since California does not offer a state income tax benefit for contributions to an in-state 529 plan, California residents prefer to invest their money in another state's 529 plan. Regretfully, other states are

getting the benefit to reinvest Californians' money in every aspect of their states' improvements to stimulate their economic activities. Alas, Gavin Newsom's premature decision to veto the bill deprives Californians from enjoying the benefits of their own investments even though California could


prosper further.

In addition, Newsom's excuse to veto the bill due to investing in Cal Grant, the largest source of California state funded student financial aid, can be disruptive to the middle class income taxpayers even further. One of the requirements to be eligible for Cal Grant is that one must be "AB-540 eligible". In 2001, Gray Davis (who was recalled in 2003) signed Assembly Bill 540 into law which allowed access for undocumented students to in-state tuition rates at California's public colleges and universities. Currently, there are an estimated 13,500 undocumented students enrolled in both the UC and

PROPOSED HOUSE GENDER-NEUTRAL RULES CALIFORNIA'S OFFICE OF ELECTION CYBERSECURITY


Wokeness is a driving force of the universities. The Trump administration drove a spike into the PC political speech that was foisted on us by the progressives.

According to a news release, the
117th Congress would "Honor All
Gender Identities By Changing
Pronouns And Familial Relationships
In The House Rules To Be Gender Neutral."

For example, in clause 8(c)(3) of rule XXIII which deals with the prohibition on hiring relatives: it would ban: father, mother, son, daughter, granddaughter. grandson, brother, sister, uncle, aunt, first cousin, nephew, niece, husband, wife, father-in-law, mother-in-law, son-in-law, daughter-in- law, brother-in-law, sister-in-law, stepfather, stepmother, stepson, stepdaughter, stepbrother, stepsister, etc.

California's Office of Election Cybersecurity - under the Secretary of State Alex Padilla


Social media users are urged to report "misleading information" to the Secretary of State's office. This California government office was created by California

Democrats to "monitor hashtags, classify political speech it opposes by 'threat level,' take screenshots of posts, and then to store the information indefinitely before reporting the offending speech to social media companies for censorship". (Daniel Greenfield, Frontpage Mag. 7 January 2021) Jenna Dresner, the senior public information officer for the Office of Election Cybersecurity, is a member of the Los Angeles County Young Democrats and formerly worked

for Rep. Karen Bass, Attorney General Xavier Becerra, and other Democrats; thus, this is a potential Democratic censorship of Republicans and Independents on social media.

Padilla's Vote Safe California campaign was run by a political/public relations firm which was a top advisor to the Biden Campaign. This firm developed Biden's vote-by-mail programs in Pennsylvania, Arizona, Michigan, and Wisconsin. California owes more than \$34 million to

this firm. Padilla quietly invited several firms to submit proposals for this campaign. (Orange County Register, by Susan Shelley, December 6, 2020).

The Secretary of State office tweeted, "The Office is a non-partisan government arm dedicated to ensuring your vote is safe."

Instead of going after hackers or voter fraud, the Office is spying on what citizens are saying online and sending the speech and views that they want censored to the big tech companies, to do their dirty job. Those are the same tech companies that censor conservatives on line, and that took off President Trump from Twitter Facebook, etc.

Corruption is one thing. Government censorship of complaints about corruption is another.

There is nothing nonpartisan about the Office of Election Cybersecurity in California.

Globalization has taken over in the Western business world. "One major goal of capitalism is to optimize costs for the production of goods. For many years, the world was viewed, by multinationals, as almost a single production source. In other words: It is okay if there is increased unemployment in Western countries if we can buy more cheaply from low-cost producers. International trade increased accordingly. California State University systems who are enjoying Cal Grant and other state financial aid through the California Dream Act, AB-130, that was signed into law in 2011 by governor Jerry Brown.

Let us not forget that in order for the average citizen college student to be eligible for Cal Grant, one has to meet low-income standards based on his/her household size. Therefore, Newsom, being short sighted and ignorant of middle class families, made an unscholarly move to veto AB-211. As he is currently experiencing political unrest while Californians fill out petitions for his recall, both Democrat and Republican residents should take their financial circumstances into consideration and realize that they could have been in a better financial position by far if Newsom had a better understanding of economic improvements and the true meaning of being an American middle class taxpayer.



CALIFORNIA LEGISLATION UPDATE

PAM LINDEMAN LEGISLATION

CALIFORNIA LEGISLATION TAKING EFFECT JANUARY 1, 2021

Governor Newsom was remarkably busy in 2020 pushing updated/new/revised Legislation through with an effective date of January 1, 2021. Below is an assortment of some of these Bills/Propositions.

SB No. 47 – Law Enforcement Uniforms

Law enforcement will no longer be allowed to wear uniforms with any camouflage and/or resemblance to military

uniforms.

AB No. 47 - Driver records: points: distracted driving

Greater restrictions to an already existing law. Your phone MUST be equipped with hands free listening and talking while driving. No longer can you hold a phone at all. Additionally, under 18 years of age is prohibited from using a wireless phone regardless if using a hands-free device.



AB No. 2717 - Motor vehicles: unattended children: liability

It is already against the law to leave a child under 6 years old in a car unattended. The new law protects the individual(s) who rescues the child from civil or criminal liability.

AB No. 685 – COVID-19: imminent hazard to employees: exposure: notification: serious violations

Effective 2021-2023, businesses must notify employees and the general public of a coronavirus exposure at the workplace within one day of exposure.

AB No. 3121- Task force to Study and Develop Reparation proposals for Africa Americans

A new law establishes a task force to study the history of slavery in the United States and how that legacy is still impacting slaves' descendants today. After researching and hearing witness testimony, the task force will recommend how reparations would be paid out in California and who would receive those payments, assuming such a program

were implemented.

Proposition 17- Parolees' Right to vote

Voters passed Proposition 17 in November 2020 which restores felons' right to vote after the completion of their sentence.

Proposition 19-Property Tax Transfers

(1) Eligible homeowners, who are 55 and older, can transfer their primary tax

assessment anywhere within the state up to 3 times.

(2) To avoid assessment of inherited property you must occupy the property as your primary residence.

SB No. 1383- Unlawful employment practice: California **Family Rights Act**

Currently employees with 50 or more employees must allow up to 12 work weeks of unpaid protected leave during any 12-month period to bond with a new child of the employee, or themselves, a parent or spouse. The new bill expands the

AB No. 979 - Corporations: boards of directors: under-represented communities

Existing law requires a minimum of one female on the Board of Directors if the principle executive office is located in CA. The new bill requires by the end of 2021-2 females directors on corporations with 5 directors. And, if the executive board has 6 directors, they must have 3 females. Additionally, by the end of 2021 a board must have at least one underrepresented community board member. Greater requirements take effect in 2021.

CALIFORNIA LEGISLATION, CONTINUED

California Family Rights Act to employers with 5 or more employees. The new bill also encompasses many more acceptable family dynamics.

AB No. 901- Juveniles

This bill revises and recast those provisions to repeal the requirements that those habitually truant, insubordinate or disorderly pupils be brought to the attention of the juvenile court and the pupil's probation or parole officer. The bill repeals the authority of the court to require the delivery of a pupil who is habitually truant, insubordinate or disorderly pupils to school daily and the respective bond provisions.

AB No. 376-Student Loan servicing

This bill imposes new requirements on a student loan servicer, requirements include the timely posting, processing, and crediting of student loan payments, applying overpayments consistent with the best financial interest of a student loan borrower and applying partial payments to minimize late fees and negative credit reporting.

SB No. 793-Flavored tobacco products

This law would ban the sale of all flavored tobacco products in California. The goal, lawmakers say, is to make these products less appealing to children and teens. However, just before the end of 2020 California state officials agreed to DELAY the ban after opponents led by tobacco companies said they filed enough signatures to put a new law to a statewide vote.

CFRW Capitol Update January 14, 2021

The California Federation of Republican Women (CFRW) reviews and monitors all Bills/Propositions throughout the year and provides pertinent updates to each of the Republican Women Federated Clubs. The following information was provided by the CFRW Legislation Committee regarding some of the Bills/Propositions they will be following in 2021.

STATE BUDGET -

• Governor's Preliminary Budget - Governor Newsom introduced his preliminary budget on January 8 in the amount of \$227.2 billion. The budget covers a broad scope including \$372 million to speed up COVID-19 vaccines to all 58 counties; \$14 billion for economic recovery, advancing direct payment of \$600 to millions of Californians ("The Golden State Stimulus"). Other allocations include monies for accelerating economic recovery and job creation which includes \$1.5 billion for infrastructure, \$1.1 billion relief for small business, \$353 million for workforce development, and \$385 million investment to build a more sustainable agricultural industry. There are many more allocations that will be addressed in the coming weeks.

HOUSING-

• SCA 2- Public Housing Projects This bill would require a vote to amend the constitution of California to allow for the construction of 100% affordable rental units without a vote of the local electorate. A vote is not required.

WATER/AGRICULTURE-

• AB 125-Food and agriculture: climate crisis: COVID-19 recovery. This bill defines the intent of the Legislature to enact subsequent legislation to issue a bond to support solutions to the climate crisis and recovery from the COVID-19 pandemic that would create a more equitable and resilient food and farming system

ELECTION LAW-

• **SB 29 - Elections: vote by mail ballots.** Extends the requirement to mail a ballot to every registered voter for all elections prior to Jan. 1, 2022. Hearing scheduled for 1/14/21.

EDUCATION -

• SB 14- Pupil health: school employee and pupil training: excused absences: youth mental and behavioral health. This bill would include another type of required excused absence an absence that is for the benefit of the mental or behavioral health of the pupil. On or before January 1, 2023, a local educational agency shall certify to the department that at least 50 percent of its employees who have direct contact with pupils have received the youth mental and behavioral health training.

EMPLOYMENT/JOBS-

• SB 74- Keep California Working Act. Help for small businesses -Appropriate the sum of two billion six hundred million dollars from the General Fund to the Office of Small

Business Advocate for the purpose of administering the program.

HEALTHCARE -

• **AB 112 Medi-Cal eligibility**- This bill would require the suspension of Medi-Cal benefits to an adult or juvenile inmate of a public institution to end on the date they are no longer an inmate of a public institution or 3 years (currently it's 1 year) from the date they become an inmate of a public institution, whichever is sooner.

INFRASTRUCTURE -

• SB 45- Wildfire Prevention, Safe Drinking Water, Drought Preparation, and Flood Protection Bond Act of 2022 - if approved by the voters, would authorize the issuance of bonds in the amount of \$5,510,000,000 to finance projects, including restorations such as, (I) Road elimination or road improvements to prevent sedimentation in streams.
