KEYNOTE SPEAKER NONIE DARWISH

Nonie Darwish authored four books, "Wholly Different; Why I Chose Biblical Values Over Islamic Values", "The Devil We Don't Know; the Dark Side of Revolutions in the Middle East", "Cruel and Usual Punishment" and "Now They Call Me Infidel."

Nonie is a human rights activist and a Middle East expert. In 2009, she co-founded www.FormerMuslimsUnited.org (FMU); FMU stands for freedom of religion and to protect the life and civil rights of people who were born in Islam and wish to leave their religion. In 1994, Nonie founded www.ArabsForIsrael.com to promote understanding, peace, and a new paradigm for how Arabs could view Israel.

Nonie was born and raised as a Muslim in Cairo, Egypt and Gaza and lived under Islamic Law, Sharia. She lived in the heart of the Arab-Israeli conflict during the 1956, 1967 and 1973 wars.

Nonie covers topics related to human rights, women's rights, Islamic law, the Arab Israeli conflict, terrorism, radical Islam and its agenda. She lectures extensively on college campuses across the USA and internationally. She was published in the Guardian and Wall Street Journal and appeared on CNN, Fox, MSNBC, C-SPAN, BBC and Al Arabiya. She spoke before the European Parliament, members of the British House of Lords and debated twice at Oxford University. She is a regular guest on many radio talk shows and was featured in several documentary films including 'Obsession'. She has been given several awards for courage was nominated for the Civil Courage Prize of The Train Foundation in New York.

PRESIDENT'S MESSAGE

Greetings fellow Republicans. I thank you for your patience as we worked to reschedule our luncheon from December to January and then to finally meet in February. It

As many of you are aware the Gavin Newsom recall campaign is looking very good. We now have over 1.9 million signatures and are looking to get 2 million before the March 17th deadline. A total of 1,497,709 valid signatures must be collected and verified to trigger the recall election. Election officials have until April 29 to verify signatures. JULIA BROWNLEY'S RESOLUTION FOR ELIMINATING SOCIAL DISPARITIES


In the 2020 Congressional debate, Julia Brownley, an incumbent since 2012, was asked, “does the government have a role to play in reducing and eliminating social disparities?” Also, if there are concrete steps she plans to take “to improve the lives of the diverse constituents” in her district? She stated, “collectively the federal, state, and county governments have a role and responsibility in this”. Continuing her response, she suggested multiple resolutions including “to spend much more in education because California doesn’t invest in education, a lot more affordable housing, equal pay for equal work, raising the minimum wage, paid sick leave, paid family leave, and implementing childcare which impacts black women most specifically and typically because they are single parents and have to be responsible for their children”. Julia Brownley has shown concern for the 2.4% black population in Ventura County while the percentage of single black mothers in her district remains unknown.

Although in debates, the questions and answers play a minimal role for candidates to attract voters, it is necessary to analyze the Congresswoman’s

understanding of reality among her constituents. Brownley, former California State Assembly Member (2004-2012), including being the Chair for the Committee on Education for three years, believes “the state doesn’t spend enough in the education arena”. According to a recent census report, Ventura County educational attainment is 86.5% which is about the same as the 88.6% rate in the United States, which is a little higher than the 84% rate in California. Moreover, the constituents’ rate with a bachelor’s degree or higher is 34.8%. While it is about the same as the 35% rate in California, it is a little higher than the 33.1% rate in the United States. Therefore, Brownley who started her public career as a member of the Parent Teacher Association (PTA) should be aware that education cannot be a reason for social disparity in her district. In fact, in 2020-2021, the total K 12 funding per student will grow to \$12,619.

Sadly, 7.6% of people in Ventura County live below the poverty line. While per capita income is \$40,293, the median household income is \$92,236 which is about 20% higher than it is for the entire state of California: \$80,440. Therefore, poverty in Ventura County or anywhere else can be solved with an increase in jobs per household. Unfortunately, Brownley has been a big supporter and promoter of Climate Change ideology. Her carbon emission clouded mind not only missed promoting job opportunities in her district,

but also destroyed the small businesses or scared them away by arbitrary tax increases. Her thought processing is too limited to grasp the idea that job opportunities can eliminate poverty and social disparities in any society. Unlike Brownley, any intelligent individual knows that equal pay for equal work, raising the minimum wage in 2024, paid sick leave which currently exists, and paid family leave will not decrease the socioeconomic gap. These elements only delay poverty and have a minimum positive effect. Nevertheless in her 2012 debate, her opponent, Tony Strickland, stated that Julia Brownley

With fewer interactions like these in the past year, our view of our fellow Americans has been distorted by social media and the news, which relentlessly focus on the most disruptive and negative forces in our country.

"has a track record of voting for tax increases that falls disproportionately on hard working California families, has voted to increase the sales tax and the automobile tax, and helped to get rid of the dependent tax credit which families rely on in Ventura County".

Brownley admittedly pushes the idea that "the wealthy have to pay their fair share" not knowing "what those income tax rates ought to be, at what level should income tax liability kick in for American families, and where the right balance is". Therefore, she is vaguely a great supporter of increased taxes to impose her welfare state mentality on people in her district to remain in need of government hand outs rather than enable the millennials to dare to realize their American dreams in entrepreneurship and empowering small businesses to explore that world along with their next generations.

Beware of the New Bills Being Introduced...

February 2021 was a busy month for new, revised and absurd Resolutions and Bills being put in the hopper to be reviewed by CA Legislators. Below are highlights of some of the Bills being proposed.

ASSEMBLY RESOLUTION 18 (AR18)

Resolved by the Assembly of the State of California, that the following members of the United States Congress be permanently banned from being granted the privilege of access to the floor in the chamber of the California State Assembly. From California: Ken Calvert (R-CA); Darrell Issa (R-CA); Devin Nunes (R-CA); Kevin McCarthy (R-CA); Mike Garcia (R-CA); Jay Overnolte (R-CA).

SB-56-MEDI-CAL ELIGIBILITY

Similar to AB-4, this bill would, subject to an appropriation by the Legislature, and effective July 1, 2022, extend eligibility for full-scope Medi-Cal benefits to individuals who are 65 years of age, or older, and who are currently not eligible due to their immigration status. The bill would delete provisions delaying implementation until the director makes the determination above. Additionally the bill would require the department to seek federal approvals to obtain federal participation to implement these requirements. The bill would impose a state-mandated county program.

AB-71 STATEWIDE HOMELESSNESS

SOLUTIONS PROGRAM-INCREASE TAXES

This Bill will attempt to solve homelessness by imposing higher taxes on people and corporations, higher corporate taxes, closing corporate tax loopholes, and repeal stepped-up basis of inherited assets. It also appears to have a retroactive element (Section 23151 (2)).

Governor Newsom's Budget for Housing and Homelessness Investment - \$10 Billion

Here are some of the more interesting budget items that are part of this investment: (a) Project Roomkey is a grant program to local government to lease vacant hotels for temporary shelter, or for converting vacant hotels/motels into permanent supportive housing for the homeless. (b) There is \$1 Billion for housing production including \$500 million each for low-income housing tax credits and infill housing infrastructure for local government to create complete communities with infill housing...meaning the development of vacant land in urbanized areas and residential neighborhoods. (c) There are eviction protections with \$11.7 million for trial courts to process the anticipated increase in unlawful detainers and small claim filings as a result of COVID.

Bad News for Governor Newsom February 18, 2021: Update by the California Federation of Republican Women

In California, a two-thirds vote is needed in each chamber of the California State Legislation to refer a constitutional amendment to the ballot for voter consideration. In 2019, a constitutional amendment was proposed, titled Senate Concurrent Resolution 2 (SAC2) in the California State Legislature. This measure would have changed our state constitution to allow an elected official being recalled to have his/her name INCLUDED in the list of replacement candidates. In 2019 the State Senate voted 28-11 to pass SCA 2. HOWEVER, it did not receive a vote in the House, so the measure failed to qualify for the 2020 ballot. Therefore, should the majority vote to approve the recall of Gavin Newsom later this year, his name WILL NOT appear as a replacement candidate in the recall election he is facing.

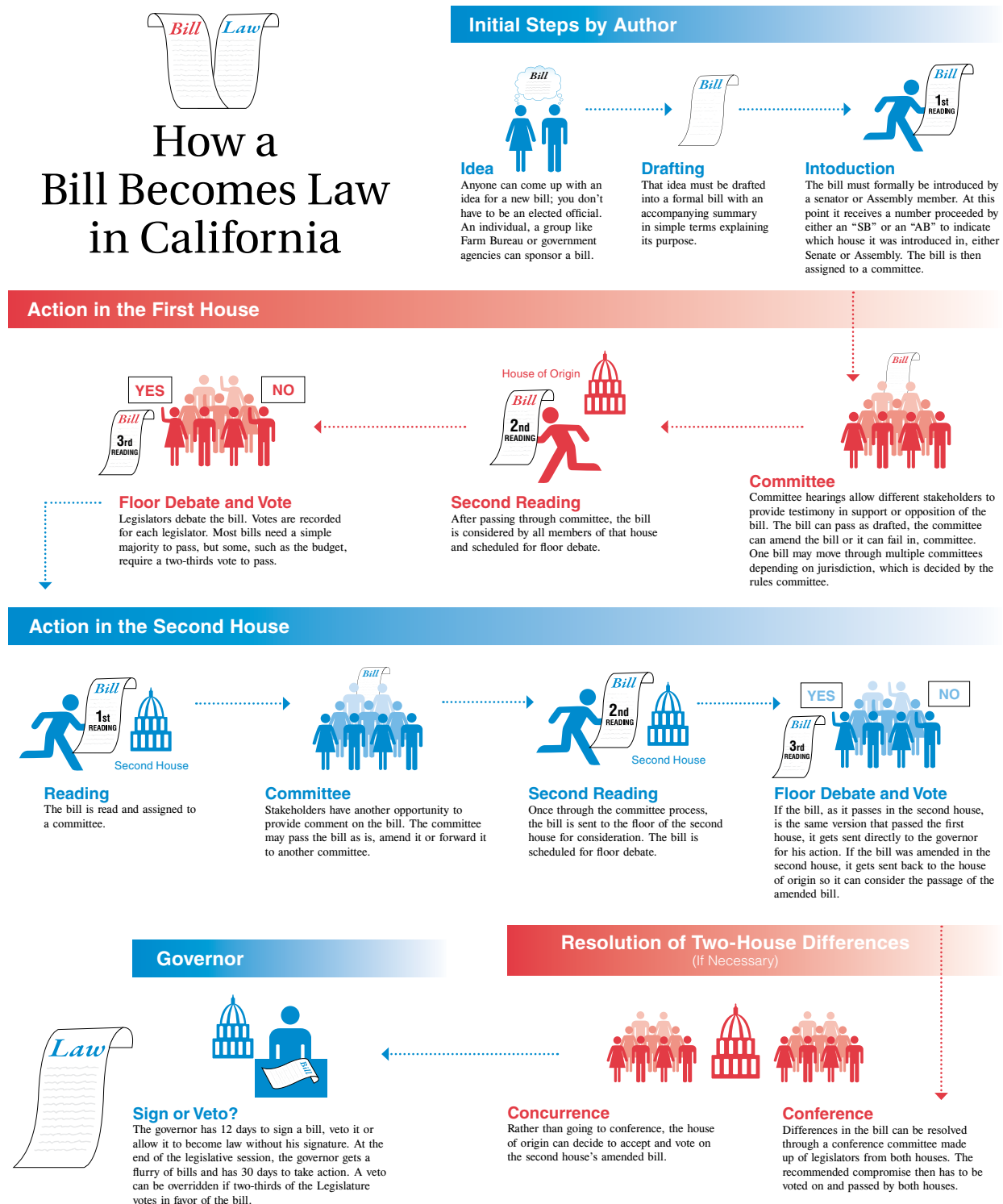
How a Legislative Bill Becomes Law in California

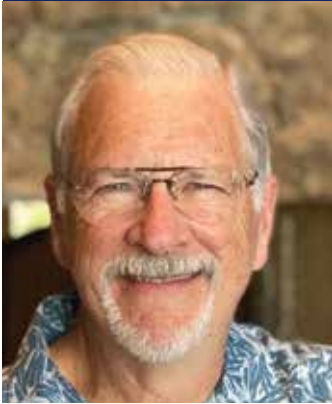

THE BOLSHEVIKS HAVE ARRIVED

Not long after the October Revolution, my grandfather and his family fled across Siberia, Asia, and the Pacific Ocean to reach the freedoms of the United States. Their journey began after my grandparents could no longer reach their friends on a daily telephone check. Grandfather's crime was being an Engineer; that of my grandmother being a physician. This made them bourgeoisie, not helped by their apartment on Fontanka canal in St. Petersburg nor their ownership of an automobile. When my grandfather could no longer raise wages fast enough to keep up with the inflationary price of bread, he decided to send the family on an extended "vacation" on the trans-Siberian

railway. He followed 3 weeks later on a "bridge inspection tour". He carried a .32 caliber revolver sewn into the crotch of his trousers. All met safely in Vladivostok, then sneaking across the border to China and on to Indonesia and finally California.

My grandmother died not long after of a chronic illness. Grandpa did well finding many different jobs as an engineer albeit with a heavy Russian accent. My father went into chemical engineering and when he started his own family, Grandpa came to live with us. He would not speak of his earlier life, thus I learned of our family's early history indirectly through old documents and rare comments from my father. As Grandpa grew older, he gradually succumbed to dementia, and his memories of that post-Revolutionary era. He would awaken many nights screaming that "the Bolsheviks had tunneled into the house from his bedroom closet". Their violent intolerance of any but the Party line, and enforced equity in all matters economic and social, and their cancelling of people and their culture, terrified him beyond sanity. That terror destroyed his mind as he faded into a vegetative death.

He was wrong, of course. The Bolsheviks never tunneled into our house. The Bolsheviks have slowly, carefully, and completely tunneled their way into our universities, our media, our popular culture, and perhaps now our government. Grandpa, the Bolsheviks have arrived.

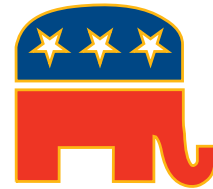
