2022 UPDATES

AB 1400: CA Single Payer Bill (known as CalCare) died on the Assembly Floor on January 31, 2022. Even the liberals are not willing to pay upwards of 20% + in State Income Taxes to pay for other non-tax payers medical expenses.

CalCare Docs.... Perspective from a Camarillo Medical Provider of AB 1400. If AB 1400 would have passed, your doctor would soon be a bureaucrat for the state of California. Although our health care system with all its jewels and foibles has evolved over decades, the state Legislature has reinvented it from whole cloth with Assembly Bill 1400. This bill in 67 pages establishes CalCare, which is comprehensive, completely free health care for all residents of California, regardless of citizenship. CalCare replaces all other state and federal health care payers and possibly private insurance too, absconding with all premiums and payments to fund all health care in the state and for those retired from California and/or travelling out of California, regardless of location.

What new bureaucracy would your doctor be joining, and when? By July 2024 an appointed CalCare Board, a CalCare Public Advisory Committee, and an Advisory Commission on Long Term Services and Supports would have been put in place without a specified source of funding and tell the state Legislature whether this detailed completely free health care plan for all (including illegal migrants) contained in this bill appears to be financially possible. The state Legislature would then “intend” to enact the system, and the public would need to approve it by proposition, after it was already in place and active! Finally, your doctor would have the choice of being paid by fee for service OR by salary (as an exclusive provider only to CalCare) both to be established by CalCare and afterwards subject to negotiation. AB1400 would reinvent and duplicate our entire health care system of payment, cost containment, new facilities/equipment decisions, quality of care monitoring, rate of your use of health care, certification of doctors, and even where training doctors and nurses may work! Your doctor would be required to duplicate frequent reports on the details of medical practice to CalCare, besides already reporting to the Federal government and private payers. According to this bill, your doctor may only contract with CalCare to provide health care only to CalCare patients which will be all persons residing in California. Providing care to people with other health care coverage or privately will result in your doctor being fined and excluded from

CalCare for a minimum of two years, effectively ending that doctor's career, in California.

Given that your doctor cannot refuse to see all comers with CalCare insurance, who have no personal responsibility to pay for any aspect of their health care (including medications, apparently), when will you be able to get an appointment? How soon will your doctors and hospitals be overrun with health care migrants from other states and other countries? Where will the funding for markedly expanded health care services without consumer or employer payment be found, especially since this new system will be initially without any redirected Federal, state, or private health care monies and have eight years to prove its worth? AB1400 would control every aspect of your doctor's medical practice, while addressing none of the consequences for your doctor or you. As millions of health care migrants from our country or other countries flood California, many of your doctors would retire or leave the state for greener pastures and lower taxes. If AB1400 had passed, at your next office or hospital visit you would be confiding to a new State bureaucrat with allegiance not to you, but to CalCare.

SB-866 Minors: Vaccine Consent Bill co-authored by Senator Scott Wiener and Senator Josh Newman, January 2022. SB 866 builds on existing Law, which currently allows minors 12 and over to make choices about their bodies around reproductive health care. SB 866 will lower the age of consent for all vaccines from 18 years to 12 years old. This means children ages 12 through 17 can, without a parent's knowledge or consent, receive the COVID-19 Vaccine at school, a pharmacy, or a clinic.

SB-871 Public Health Immunizations Bill authored by Senator Pan (D), aims to add the COVID-19 Vaccine to the list of already mandatory immunizations schedule required for students (K-12) to attend school. Students will be required to get the COVID-19 vaccine to attend school by January 1, 2023, even though vaccine does not have full FDA approval. SB-871 will also remove any Personal Belief exemptions that would allow parent to decide not to have their child vaccinated.

Although the D-R Party later evolved to become the Democratic Party, the original party favored a decentralized government, something supported by modern-day Republicans.

The Republican Party was formed in the 1850s, when members of various political groups held a political convention dedicated to opposing the extension of slavery in the United States.

American politics became a two-party system in the 1860s as a direct result of the rapid success of the Republican Party in dominating all other parties opposed to the Democrat Party.

Theodore Roosevelt was a popular Republican president who chose not to run for a third term. However, when he decided he didn't like Republican Taft's policies, he formed the "Bull Moose Party," dividing the Republican Party for a few years.

CALIFORNIA SURPLUS OR IN DEBT?

On January 18, 2022, Governor Newsom talked about his budget which included a huge surplus of \$48 billion.

No mention was made of California's state and local governments staggering debt of \$1.5 trillion. In reality, the state has no clue as to how much it is in debt. The state financial accounting system, started in 2005, is still incomplete, and millions of dollars over budget. "2020 financial reports may not be finished before the governor's budget is approved." (Bill Swaim, Orange Co. Register, January 21, 2022) There is no actual surplus. Much of that money owed is to the retirements of government workers, which also depends on the stock market. If the stock market drops, personal income tax and capital gains tax revenue will decline, and the so-called surplus will be wiped out. The state's unions push the story of surpluses and bury the long-term liabilities. They back lawmakers with their money to raise taxes and add more debt. Future generations are left to tackle the problem of debt. Are reporters reporting on this? There are few that bring up the problem of debt in California. Most are reporting on how the state will spend this "fictional" windfall.



Pension problems of some of our local cities:

According to a recent Grand Jury report, Santa Barbara City pensions shows that the city has unfunded pensions of \$392,000,000. The city's current total 2022 budget is \$391,968,325.

At the Camarillo City Council meeting of July 11, 2021, the council voted unanimously to take \$5 million out of the city's general fund and place it in a Pension Rate Stabilization Program trust managed by PARS. The city's stated goal is to pay down its \$30 million in unfunded liability debt over a period of 20 years.

By Venturans for Responsible & Efficient Gov't: "Ventura's unfunded pension liabilities continued to grow in 2019 to \$218.6 million. The City of Ventura continues to sink deeper into debt to pay for city employees' present and future retirement benefits." "The new unfunded pension liabilities figures come from the 2018-2019 Comprehensive Annual Financial Report (CAFR). Ventura added \$3.5 million to its unfunded liabilities.

Simultaneously, the market value of Ventura's assets held by CalPERS dropped to 66.7%, a multi-year low."

"Discussions about pensions get emotional because we're talking about people's future and security. Let's be clear. We respect the work city employees do. There is no denying that fire and police perform a vital job that is both dangerous and requires a high level of training and responsibility." "Our concern is not about their work. We're uneasy about how the city structures, accumulates and pays retirement benefits." "Neglecting The Unfunded Pension Liabilities Doesn't Make Them Disappear."

RECAP OF ELECTION INTEGRITY PROJECT CA PRESENTATION

At our February 8, 2022 General Meeting/Luncheon, Members and Guests had the opportunity to hear Gloria Massey Chinae, VC Election Integrity Project CA (E.I.P.Ca), Coordinator and three E.I.P.Ca Team Experts speak on the electoral process as the cornerstone of self-governance and the preservation of our Constitutional Republic. Expounding on the fact that the right to choose our representatives by fair and honest elections is layered with fraud.

***Why does CA have 1.8 million more registered voters than eligible citizens and why did this average rise by 72% in the 2020 election cycle?**

***Why did California's on-line DMV registration systems change 33,000 foreign born voters' birthplaces of record to "CA" or "United States"? Thus, potentially making non-citizens unlawfully registered to vote.**

Two major lawsuits have been filed by E.I.P.Ca:

2. **State Civil Rights Lawsuit: CA State Superior Court lawsuit in Ventura County.** Main issue at hand is that **they have called this election a "vote by mail election", and it is not. As citizens you can vote in person and request, on demand, a paper ballot and vote in person. There are 4 areas that the U.S. Constitution has been violated.**

The overall presentation, which really brought the importance of understanding the electoral process, was very good and well received by the attendees. The absolute need for oversight of voting by an independent citizen-based organization is vital to ensuring that each lawfully cast vote is accurately counted, whether or not voting takes place at a polling station, by mail, or electronically here in California and Nationwide.

Elections Belong to the People. The Constitution of all 50 States mandate that voting is a privilege given ONLY to legal citizens. California's Election Code guarantees every registered citizen ONE, privately cast, uninfluenced vote that is accurately tabulated. Volunteers are needed to help E.I.P.Ca continue to fight for the preservation of each lawfully cast vote accurately counted in every California Election.
