CRWF WELCOMES KEYNOTE SPEAKER CHRISTOPHER HARRIS, US BORDER PATROL (RETIRED) THE SOUTHERN BORDER IS OUT OF CONTROL



Mr. Harris was a union leader who represented 2,000 Border Patrol agents in the San Diego sector. He served as Director of Legislative and Political Affairs for the National Border Patrol Council, Local 1613. He has led U.S. Presidents and a myriad of groups, from Congress members to the media, to areas of the U.S. border, offering not only facts about the number of illegals using the U.S. Borders to come into the United States, but also insights into the thinking of the agents who patrol the border. Mr. Harris will speak about the fact that borders were nonpartisan until 2015.

Working under five U.S. President's Administrations, Chris will share his perspective as to why Joe Biden is the worst of the five Administrations he worked for.

Right now, under President Biden's leadership, the Southern Border is out of control. In 2021 alone there were 2 Million apprehensions. And 500,000 "got-aways". One third to one half of the "got-aways" are criminals, gang-bangers or cartels. Mr. Harris will discuss the three ways for illegals to come into the United States: refugees, immigration and seeking asylum. He will speak about the need for the "Border Fence". "As a nation we will not be able to control entry criminals, illegal deadly drugs, and the cartel into our Nation if we do not control the Borders."

LEGISLATION AND ACTIVISM

SB-1384 - GUN STORE REGULATIONS

This bill requires all licensed firearm dealers to have a digital video surveillance system meeting certain standards, to have general liability insurance coverage of at least one million dollars, and to require certain training for all employees annually. This is a very encompassing bill that puts many requirements on gun store owners.

SB-1327 - CIVIL LIABILITY GUNS

This bill creates a private right of action that allows individuals to file civil suits against anyone who manufactures, distributes, transports, sells or imports firearms banned in California, as well as precursor firearm parts. Current law allows for remedies for illegal activities by firearm dealers and manufacturers.

AB-1621 – FIREARMS: UNSERIALIZED FIREARMS

This bill expands what is considered a "precursor part" under existing law and requires serial numbers on those parts. Further, it expands the definition of a "firearm" for purposes of criminal and regulatory penalties to include "precursor parts". And, it prohibits the possession, transfer, sale or advertising of milling machines that have the sole or primary purpose of manufacturing firearms. Unfinished frames or

receivers are not regulated as firearms under federal law; however, they are already regulated under state law and are limited to being transferred by licensed vendors in California.

AB-2193 – CIVIL REPRESENTATION: IMMIGRATION STATUS

Existing law, the Sargent Shriver Civil Counsel Act, requires legal counsel to be appointed to represent low-income parties in civil matters involving critical issues affecting basic human needs in courts selected by the Judicial Council The act requires the Judicial Council to develop one or more programs involving specific types of civil matters, including, among others, housing-related matters, probate conservatorships, guardianships, and domestic violence and civil harassment restraining orders. This bill would require the programs to provide services without regard to the citizenship or

immigration status of the person represented, and if an organization is prohibited, due to other funding restrictions, from representing certain persons due to their citizenship or immigration status, would require the organization to refer those individuals for services elsewhere.

AB-1797 – IMMUNIZATION REGISTRY

This bill would require health care providers and other agencies, including schools, childcare facilities, family childcare homes and county human services agencies to disclose the specified immunization information, and would add the patient's or client's race or ethnicity to the list of information that shall or may be disclosed.

The bill would additionally authorize schools, childcare facilities, family childcare homes and county human services agencies to use the specified immunization information, in the event of a

public health emergency, to perform immunization status assessments of pupils, adults and clients to ensure health and safety.

Existing law requires schools, childcare facilities, family childcare homes, and county human services agencies to maintain the confidentiality of the specified immunization information and to only use the information for specified purposes, including to carry out their responsibilities regarding required immunization for attendance or participation benefits, or both. AB-1797 will

change the confidentiality of the information with broad reporting.
