

Her first book, *Plague of Corruption, Restoring Faith in the Promise of Science*, co-authored by Kent Heckenlively JD, is a New York Times

Do we really need to wear masks??? # NOVEMBER 8, 2022 ELECTION BALLOT MEASURES

All Amendments to the California Constitution must be placed on the Ballot where voters will vote for or against the Amendment. The following Amendments/Ballot Measures will be on the November 8, 2022 ballot:

**Proposition One SCA-10 Reproduction Freedom:** The California Legislature's constitutional amendment inscribing abortion rights at the heart of California Law. A budget bill bestowed the ballot-leading Prop One designation. This is a constitutional amendment authorized by the State legislature in response to the Supreme Court decision of Roe vs. Wade.

The California Constitution declares that defending life and liberty, acquiring, possessing, and protecting property, and pursuing and obtaining safety, happiness, and privacy are inalienable rights, and that a person may not be deprived of life, liberty, or property without due process of law or equal protection of the laws. The constitution does not specify the right to contraption or abortion. Existing law, the Reproductive Privacy Act, declares that every individual possesses a fundamental right of privacy with respect to personal reproductive decisions and prohibits the state from denying or interfering with a person's right to choose or obtain an abortion EXCEPT that performance of an abortion is UNAUTHORIZED if either of the following is true:

1. The person performing or assisting in performing the abortion is not a health care provider authorized to perform or assist in performing an abortion pursuant to Section 2253 of the Business and Professional Code.
2. The abortion is performed on viable fetus, usually 23 weeks, and both the following are established: in good faith medical judgement of the physician: (a) the fetus was viable and (b) continuation of the pregnancy posed no risk to the life or health of the pregnant woman.

**State Constitution Act 10, was passed by the California Legislature on June 27, 2022.** This Act would enshrine abortion by amending the California Constitution. Under the Amendment, the legislature and future lawmakers would be prevented from placing reasonable limits on abortions. The language of the Act prohibits the state from denying or interfering with an individual's right to choose to have an abortion and the right to choose or refuse contraceptives. The Act does appear to limit "reproductive freedom" to abortion and the freedom to choose contraceptives. It also does not reference the previous language in the California Health and Safety Code that specifies when abortions are not authorized. The vague language of SCA10 about "reproductive freedom" is open to wide-ranging interpretation.



The measure would amend the California Constitution to prohibit the state from denying or interfering with an individual's reproductive freedom in their most intimate decisions, which includes their fundamental right to choose to have an abortion and their fundamental right to choose or refuse contraceptives.

## **Proposition 26 California Legalize Sports Betting on**

**American Indian Lands: Would legalize sports betting at American Indian gaming casinos and licensed racetracks in California.** Native American tribes' measure allowing sports betting on tribal land. This is one part of a gambling standoff that will likely shatter spending records, along with Prop 27. Card rooms, Tribes' perennial nemeses, just added \$3.2 million more to defeat this measure.

The ballot measure would define sports betting as wagering on the results of professional, college or amateur sport and athletic events, except for high school sports, and events

featuring California college teams. The ballot measure would also legalize roulette and dice games, such as craps, at tribal casinos. Individuals would need to be 21 years of age to engage in legal sports betting.

The measure would enact a tax of 10% on profits derived from sports betting at racetracks. The State government would be required to distribute the revenue as follows: (a) 15% to the California Department of Health for researching, developing and implementing programs for problem gambling prevention and mental health and providing grants to local governments to address problem gambling and mental health; (b) 15% to the Bureau of Gambling Control for enforcing and implementing sports wagering and other forms of gaming within the state and; (c) 70% to the general fund of the State.

Support comes from The Coalition to Authorize Regulated Sports Wagering, which is supported by several American Indian tribes including, but not limited to: The Pechanga Band of Luiseno Indians, Federated Indians of Graton Rancheria, and San Manuel band of Mission Indians. Opposition is from Taxpayers against Special Interest Monopolies, and gambling related companies such as: CA Commerce Club, PT Gaming LLC, Knighted Ventures LLC, and Hawaiian Gardens Casino.

**Proposition 27 California Legalize Sports Betting and Revenue for Homelessness Prevention and Fund Initiative:** Platforms like FanDuel and DraftKings are spending big for the right to oversee online sports wagering, directing some of the proceeds to combating homelessness. With a couple of exceptions, tribes are going all-out to defeat what they perceive as an existential threat.

The initiative proposes a constitution amendment and statute to authorize a gaming tribe, an online sports betting platform with an operating agreement with a gaming tribe, or a qualified gaming company with a market access agreement with a gaming tribe to operate online sports betting for individuals 21 years or older in the State, but outside of Indian lands. The amendment would prohibit online sports betting on youth sports. The proposed law would create the Division of Online Sports Betting Control within the Department of Justice. The initiative would give the division authority to regulate the online sports betting industry and investigate illegal sports betting activities. The amendment would take effect on January 1, 2023. The proposed law would establish the California Online Sports Betting Trust Fund. The revenue from licensing fees, renewal, and the

sports wagering tax would be deposited into the fund. 85% of the funds revenues would be allocated to California Solutions to Homelessness and Mental Health Support Account for permanent and interim housing. 15% of revenues to the Tribal Economic Development Account, which would be established by the initiative to provide funds to Indian tribes for expanding tribal government, public health, education, infrastructure, and economic development.

Support comes from California for Solutions to Homelessness and Mental Health Support and the top three gaming donors: BetMGM LLC, Betfair Interactive US LLC and Crown Gaming. Opposition is from California for Tribal Sovereignty and Safe Gaming and the Coalition for Safe, Responsible Gaming. And several Indian Bands, the LA Urban League, La Razza Roundtable of California, and the California Teachers Association.

## THE ELITES PLAN TO RULE US - BEZOS

Amazon Founder, Jeff Bezos' new \$10 billion Earth Fund to save the planet from people, calls for a "great reset," and by 2030, most people will have to shift their modes of transportation from gas cars to expensive electric vehicles, public transportation, walking, or biking.

This applies to the "regular fellas" but not to elites such as Bezos, Bill Gates, or John Kerry.

Bezos will be able to fly around the world in his \$65 million Gulfstream G650ER private jet.

He will keep his \$500 million, 417-foot long, three-masted mega-yacht, powered by two diesel engines, which can deliver 12,000 horsepower. It has a swimming pool, 3 decks with 25 rooms, as well as a "support" yacht with a helicopter pad.

The **Earth Fund** says the economy needs to be "decarbonized," and radical changes will be needed in the way we power our world, manufacture products, grow our food - to diets of plant-based foods.

"The **Bezos Earth Fund** proposes to use satellites to "identify methane pollution, hold those responsible accountable and highlight opportunities to manage and minimize oil and gas methane emissions." – Will the satellites identify his yacht? (Daniel Greenfield, Frontpage Mag. May 18, 2022.)

Millions more are going to Earthrise Media which operates alongside the Sixteen Thirty Fund, the dark money machine of the Left, the Sierra Club, the Environmental Defense Fund, Mothers Out Front, and a variety of leftist groups in favor of the Green New Deal.

**Jeff Bezos owns 14 expensive properties.**

a. **Hawaii.** \$78 million Hawaii estate with three-buildings on 14 acres. The main building of the property is 4,450 square feet, has three bedrooms and three bathrooms. The second building is a 1,839 square feet guesthouse with two bedrooms and two-and-a-half bathrooms, while the third is 1,815 square feet with three bedrooms and one bathroom.

b. **Manhattan's Fifth Avenue.** He bought five properties over the course of three years to form a de facto mega-mansion, which encompassed 17,000-square-feet with 12 bedrooms and more than one terrace. This included a three-floor, 10,000-square-foot penthouse with a grand ballroom, a three-bedroom unit and an adjoining four-bedroom pad with massive windows, and comprising of a fitness center, golf simulator, game room, and movie screening room.

c. **Two in Washington, D.C.** The \$23 million property he bought in 2016, boasts 27,000 square feet of space and was built in 1912. He also purchased a second property for \$5 million.

d. **Washington State.** Bezos purchased two homes in his home state of Washington in 1998, which the businessman combined into one estate. The pair of properties, situated in Medina cost the-then mogul \$10 million.

e. **Beverly Hills.** Bezos has an enormous 10-acre estate that boasts of a 13,600-square-foot Georgian-style main house, two guest houses, a nursery and three hothouses, a tennis court, a swimming pool, expansive terraces, and a nine-hole golf course.

**He also is the owner of a couple of other homes in Beverly Hills.** He bought the first for \$24.45 million in 2007 and snatched up an adjacent property 10 years later in 2017 for \$12.9 million. The first was a Spanish-style mansion with a greenhouse, tennis court, swimming pool, six car garage and four fountains, containing seven bedrooms and seven bathrooms.

**Per Cal Conner** – "If Bezos really cared about the planet, then he would not have bought a golf course, removed every living plant, built a building, paved the rest, and no intention of putting any trees back to replace the ones cut down. Skyland Golf course, Canton, OH is now an Amazon building. **No, he does not care about the planet. That's been made clear.**"

- Biden won independents by 22 points, but today he is down 52 points (74 point swing).
- Biden won the youth vote by 42 points, but today he is underwater by 24 points (a 66 point swing).
- Hispanics supported Biden by 56 points, today he is underwater by 2 points (a 58 point swing).
